



## MEMORANDUM OF UNDERSTANDING

## Number 0012/UN9/MoU/LN/2021

In order to promote cooperative partnership and linkage, establish academic and cultural exchange, and foster international understanding and goodwill, **CAMARINES SUR POLYTECHNC COLLEGES** of Nabua, Camarines Sur, Philippines, and **UNIVERSITAS SRIWIJAYA** of Kabupaten Ogan Ilir, Sumatera Selatan, Indonesia, enter into this Memorandum of Understanding (MoU) and agree as follows:

The two institutions shall encourage collaboration and cooperation between their faculty, students, and institutional units, offices and departments on programs and undertakings that are considered feasible and mutually beneficial to both within their respective financial, technical, and educational capacities.

Both institutions agree to pursue the following programs and activities, subject to the creation of separate, detailed supplemental programs of implementation which are mutually agreed upon.

- 1. Faculty Visit and Exchange Program
- 2. Student Visit and Exchange Program
- 3. Short-Term Academic and Staff Development Program
- 4. Researcher Visit and Exchange and Joint Research and Academic Program
- 5. Joint Organizing of Academic Conferences, Workshops and Seminars
- 6. Information and Resource Sharing
- 7. Joint Supervision
- 8. Co-authoring of Books and Papers
- 9. Double Degree and Joint Degree
- 10. Other forms of academic and cultural exchange agreed upon by both institutions

Both parties subscribe to the policy of equal opportunities and shall not discriminate on the basis of race, age, sex, ethnicity, religious affiliation or national origin.

The Parties acknowledge and understand that any costs, expenses and financial arrangements with regard to any project or activity pursuant to or arising from this Memorandum will be subject to negotiation and prior written agreement and that any binding agreement will be subject to the availability of funds.

This agreement does not intend to diminish the full autonomy of either institution nor does it create any form of binding and legal obligations and constraints. This Memorandum shall be governed and construed with the laws and regulations in force in the jurisdiction of each cooperating Party.

All received and shared confidential information, including any visual, verbal, digital or written information, and all records containing or disclosing such information, shall be disclosed only to personnel and professional advisers involved in this collaboration on a need-to-know basis and shall only be used in respect to the matters contemplated in this Memorandum.

This agreement shall remain in force for five years and shall be renewed for another five years based on mutual consent. Adoption of any form of revision shall be subject to mutual consent. Either institution may terminate the agreement upon a six-month written notice and declaration by the terminating party. When termination affects any on-going collaborative programs and activities, both parties agree to resort to amicable resolutions and settlements.

This Memorandum of Understanding takes effect when both institutional representatives have signed and dated the document.
